Examples of tax refund calculations on a **buy and sell** transaction.

Price of Snowmobile/ATV Bought	\$ 6,000.00	\$ 4,000.00
Tax Paid (A)	<u>420.00</u>	<u>280.00</u>
Price of Snowmobile/ATV Sold	\$ 4,000.00	\$ 6,000.00
7% of Selling Price (B)	<u>280.00</u>	<u>420.00</u>
Refund Claimable by Applicant [lower of (A) and (B)]	<u>\$ 280.00</u>	<u>\$ 280.00</u>
